The following items reflect subjects discussed:

1. Minutes of 12/16/06 meeting - The minutes of the membership meeting held on 12/16/06 were approved as written in the January 2007 newsletter.
2. Treasurer's Report - There was no change in the treasury and it is the same as listed last month.
3. Checking to CD - As per a recommendation made by George Parris at the December membership meeting, we will be moving an additional \$2,000 to a CD.
4. Membership - Donna Hurst reported that to-date, we have 10 Individual and 5 Family membership renewals and 1 new member request.
5. ByLaws Change - Discussion was held to propose to the membership that the board be allowed to vote on new memberships. Presently, new members have to wait as long as three months before a membership meeting to get approval.
6. Donation - The club received a \$30 contribution from Sue Shortall in support of the DDC.
7. Thank You - The club received a very nice thank you note from Joe and Pansy Plummer for recognizing them with a 'Life-Time Membership' during our yearly Christmas Party.
8. Education - The board passed a motion to pay \$25 towards any member attending the upcoming clinic with Dana Bright.
9. Notice to Insurance Co. - John Bolinski will send a note to our insurance company detailing the dates of upcoming events. A note of insurance will also be sent to the upcoming clinic leader.
10. Photography - The board discussed using Wal-Mart to develop our photos in the future.
11. Treasury Disbursement - Discussion took place on establishing a bylaw that would address the distribution of

the treasury should the club disband. John Bolinski will research the federal law as to what it says should take place upon dissolving of a non-profit organization.

12. Future Christmas Parties - Discussion took place on where to hold the next three Christmas Parties. Since the Redden Lodge is not available in 2007 or 2008, Donna Hurst will look at the Nutter Marvel Museum for these years and Peg Koster will check the Redden Lodge for 2009.

13. Redden Carriage Drives - Peg Koster will check with Redden staff to see if the condition of the trails is good enough for carriage drives. If so, we will look at April 22, 2007 as a possible drive date.

14. Horse Show - Discussion was held on the 2007 horse show. Peg Koster, Paula Barto, Martie and John Bolinski volunteered to help with the Food Committee. Carolyn Fox volunteered to act as Show Manager if she could get help from John Bolinski. Future planning needs to take place with Carl Zimmerman and George Parris.

15. Delaware Equine Council - The next DEC meeting is scheduled for January 15, 2007 in the Harrington Library. A casual dinner dance and auction is scheduled for Friday, March 23, 2007. Music will be by the "Wild Horses". The DEC will need sponsors for the program.

16. Congratulations Note - The board asked Martie Bolinski to send a note to Danute Bright, congratulating her for the President's Award she received from The American Driving Society.

17. Lost Horse - Paula Barto presented steps that should be taken if a person loses a horse. As prevention, owners should take pictures, microchip or tattoo. Peg Koster volunteered to write an article for our newsletter.

18. Web Site - Discussion was held on whether to maintain the web site at a cost of \$170 per year. The board decided to maintain the website at this time.

**What to do if your Horse is Lost** - from the DEC Newsletter, February 2007

- Start this process immediately! A horse can and will travel 10 to 20 miles a day!
- Call the State Police, the troop closest to the area where your horse is missing,
- Call the SPCA,
- Call Horse Rescues,
- Contact everyone in the vicinity, go door to door,

- Contact local horse organizations and ask for assistance,
- Use Internet with emails and websites, ie, delawareequinecouncil.org,
- Call Radio and TV stations and ask for support,
- Contact local feed stores and tack shops, etc.,
- Make fliers and get them to friends and locals and all or any of the above mentioned. Finding your horse is the first problem.

**Identifying your horse** may be a second problem. Be proactive; have recent photos; know distinguishing marks and habits; have copies of papers, Coggins, health certificates with you. Talk with your vets about microchips or other forms of ID for your horses.

Try to be familiar with where you are riding or at least have someone with you who does know the area.

**"My Summer in Driving Paradise, Southern Pines NC" by Frances Baker**

The past summer, my husband Wayne and I sent our team of four horses to NC to school as a four-in-hand team with Bill Long. Bill is a six-time international four-in-hand Combined Driving Event champion. He trains all kinds of horses at his facility in NC.

He schooled the team for a few weeks before he called me to come down for my schooling. I had driven my older pair of wheelers (the horses nearest the carriage) for about 4 years. The leaders were young and relatively inexperienced. I had only driven them lightly. Bill was not sure the four horses would make a team, let alone that I would be able to drive them, being a novice myself. I made weekly trips down to NC for lessons accompanied by my friend, Pat Roth. Once I went alone, and, at the end, my husband went with me. We were all schooled by Bill and his groom, Manuel, on harnessing and unharnessing and SAFETY in doing so. At first I could hardly lift the harness, jump into the carriage and then drive the horses for an hour. Bill worked with me on little tips to make the harness lifting easier, at the same time reminding me that many drivers did not make it in four-in-hand driving and had to go back to pair driving. I was determined not to flunk out of driving school so I spent many afternoons at the motel pools, cooling off with 4 pieces of leather - practicing the Achenbach one-handed method of driving. Each week the driving got easier and the two months came to an end too soon and we were back home in DE on our own. My husband and friend, Pat, continue to help and the driving gets better and better each time we drive.

Bill's advice was never to take anything about driving for granted and to get all the help you can with every phase of driving.

We made many friends while we were there. Bill has a big picnic table under the pine trees by his stable and each morning, many driving friends stop by. The people I saw there, I now recognize in the driving magazines. I watched Eleanor Gallagher drive her beautiful Dutch horse, Cashmere, preparing for the World Single Finals in Italy this past fall. Bill was her coach. Cashmere was known to shy in Europe at the crowds so Bill drove him through downtown Southern Pines and up to the bank drive in window. When the bell rang at the drive-in window, Cashmere left a horse "deposit" in the parking lot.

We also became good friends with Bob and Susie Cook, formerly from MD, who now live in Southern Pines. Bob and Susie own WCC (World Class Carriages) and import and sell all kinds of carriages. Bob and Susie and almost everyone in Southern Pines own and live in barn homes. It is the norm down there. If you have never been there, by all means go. In addition to the acres and acres of state parks, there are miles and miles of hard-scraped dirt roads for driving and easements between each of the homes where anyone can drive. It is an easy one day drive away and well worth the trip. The CAA Conference is there this coming April.

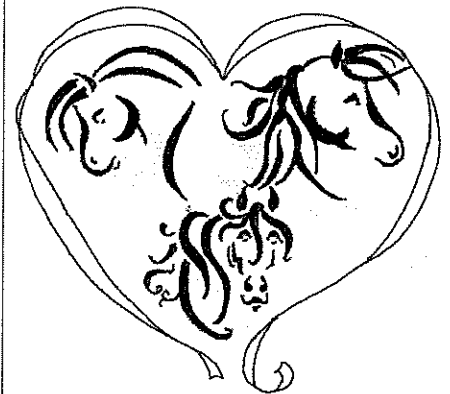

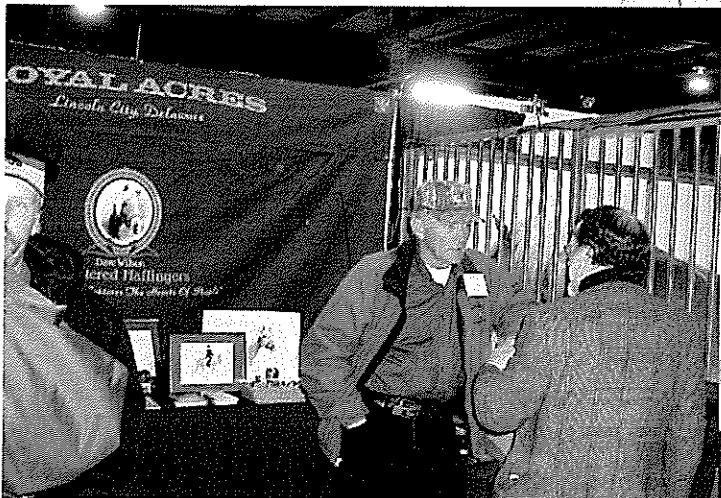

### Directions to Anna Klump's Farm - Dana Bright Clinic:

From north: Take 213 S to 298, bear right. Go about 3-4 m. and bear right onto 566. 8/10's mile after that, you bear right again, into Medder's Lane/Rosedale Cannery Rd. The landmark is a white house on the right, then a square sign saying is is 292. The very next lane bearing to the right is IT. Very hard to see! Go about one mile to the stop sign on Eagle's Next Lane, take that lane about 1 mile (after the right hand turn and a left hand turn past the neighbor's horse ring). The very next lane is mine.

From South: 213 through Chestertown. Turn left onto 561 to a T stop in Lynch. Go right to 292. Take that into Still Pond. At the stop sign, go straight onto Main/Trustee St. It will go right, then at the stopsign, take the left to Rosedale Cannery and follow the directions above.

From the East: Take 291 to the east from 301. (291 is Rt. 6 in DE) into Chestertown. Turn right onto 213. Go up to 561, about 3-4 miles and turn left by the animal hospital (before the Thormar sign) and take this through Lynch. Follow directions above.

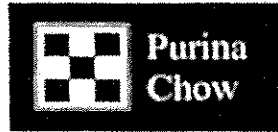

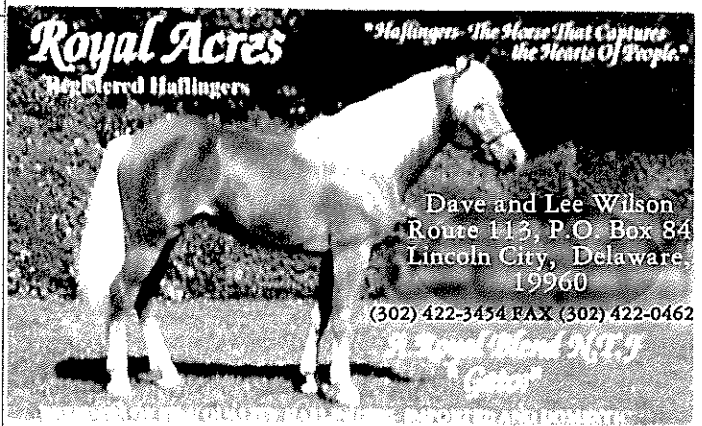
